आदेश

हरिदेव जोशी पत्रकारिता और जनसंचार विश्वविद्यालय, जयपुर अधिनियम की धारा 26(1) के अनुसरण में वीक्षांत समारोह में वितरित किए जाने हेतु डिग्रियों, वरीयता प्रमाण-पत्र एवं स्वर्ण पदकों के संबंध में गठित पुनरीक्षण समिति की अनुशंसाओं के अनुसार निर्धारित शिथिलों की स्वीकृति विश्वविद्यालय के संशोधित आदेश क्रमांक 19339 दिनांक 04.02.2023 के अतिक्रमण में विद्यापरिषद एवं प्रबंध बोर्ड के अनुमोदन की प्रत्याशा में विश्वविद्यालय के अधिनियम की धारा 11(19) में कुलपति महोदय को प्राप्ति शक्तियों के आधार पर निम्नानुसार जारी की जाती है:

CRITERIA FOR AWARD OF GOLD MEDAL IN UNDERGRADUATE & POST GRADUATE DEGREE PROGRAMMES

- (i) The students of each Under Graduate and Post Graduate Degree Programmes of Four/three years and one/two years respectively secured highest marks/CGPA shall be eligible for Gold Medals provided his/her CGPA is at least 6.5. If more than one student secures same highest marks and stand at first position then all such students shall be eligible for Gold Medal.
- (ii) Revaluation/Scrutiny result shall be considered for the calculation of Highest Marks of the Programme.
- (iii) Student should not have ever failed or designated due (back) during the courses of study.
- (iv) Absence in examination of any of the paper or semester shall make student ineligible for Gold Medal.
- (v) Student should not have been put on conduct probation during the course of study.
- (vi) Student should have completed all the requirements including submission and passing of Dissertation for degree in stipulated minimum period, as prescribed in course curriculum.
- (vii) The University reserves the right to not to award a Gold Medal without assigning any reason.
- (viii) Gold Medal shall only be awarded subject to minimum 10 (ten) students found eligible for award of degree in such programme or a regular class is formed in the session irrespective of the number of students.
- (ix) In case the candidate standing first in order of merit does not fulfil the condition laid down above, he/she shall forfeit his/ her claim to the medal, which shall not be awarded in that year.
- (x) The medals will be awarded at the Annual Convocation of the University.

CRITERIA FOR ORDER OF MERIT

- (i) Merit Certificates shall be issued to top 03 (three) candidates standing in order of merit at an examination of the University and the candidate bracketed with the third candidate, if any, irrespective of the division obtained by them. If more than one student secures same highest marks then all such students shall be eligible for same merit.
- (ii) Student should not have ever failed or designated due (back) during the courses of study. Absence in examination of any of the subject or year shall make student ineligible for order of Merit.
- (iii) Order of Merit shall not be issued for certificate and Diploma Examination.
- (iv) Order of Merit and Merit certificates shall only be awarded subject to minimum 10 (ten) students found eligible for award of degree in such programme or a regular class is formed in the session irrespective of the number of students.
- (v) No fee shall be charged for issue of merit certificate of examination.
- (vi) A Duplicate copy of the merit certificate shall be issued on payment of a fee of Rs. 500/- or as decided from time to time.
- (vii) Revaluation/Scrutiny marks shall be considered for making order of merit for the Programme.
